Global Gateway: A global connectivity strategy to shape EU infrastructure investments

11 March 2022, 10.00 – 11:30 hrs.

In her 2021 State of the Union Address, the President of the EU Commission, Ursula von der Leyen, introduced a **new connectivity strategy** called **Global Gateway** to foster **partnerships** with countries and bring institutions and investment, banks and the business community to deploying quality infrastructure and connecting goods, people and services around the world.

The new connectivity strategy contributes to the diversification of value chains, reduces strategic dependencies and boosts competitiveness for the EU and its partners. Global Gateway / Global Europe is to become a trusted brand around the world, with a long-term vision and a values-based approach that offers transparency and good governance to EU partners.

Team Europe plays an instrumental role in the new connectivity strategy, and particularly the new EIB Development Branch (EIB Global), to better manage EU investments outside the European Union.

EIC and EFCA both welcome the Global Gateway and the creation of a development branch within EIB, considering that they are steps in the right direction of having an integrated and strategic vision of infrastructure investments worldwide and of creating a level playing field around EU values, standards, and principles.

In our **joint webinar “A global connectivity strategy to shape EU infrastructure investments”** we aim at getting a better understanding of the strategy, its implementation and roles of the players involved. The private sector is placed at the heart of this initiative, and it is essential to align the vision and to structure the dialogue between EU institutions and the private sector to make this strategy a success.

Takeaways from EC, EIB, AFD and KfW:

- Priorities to structure a pipeline of high impact and visible infrastructure projects globally
- Instruments to finance infrastructure investments and use technical assistance funding
- Role of Team Europe and the mechanisms to ensure cooperation and coordination between EU development finance institutions
- Specific role of EIB’s Development Branch

Messages from the private sector (EIC, EFCA):

- Preparing high-quality, policy-aligned investment projects
- Procurement principles and procedures that ensure quality and a level-playing field
- Creating a business-friendly environment to attract companies and investments to high-risk/ high-complexity markets with many institutional players (particularly SMEs).
